- Municipal officials file with the city clerk or recorder.
- City attorneys file with the city clerk or recorder.
- Members of regional boards or commissions file with the county clerk of the county in which they reside.

### 90 DAYS BEFORE FEDERAL ELECTION

County Clerks: NVRA § 8 removal process shall cease as the "90 days before a federal election" date when NVRA § 8 removal is prohibited. Removal of voters pursuant to §8 could resume after any primary runoff in June, but must stop again 90 days before general election UOCAVA date. Statutory and Constitutional exceptions (allowing removal of felons, decedents, etc.) continue to be allowed.

The absentee ballot application for those voters shall remain in effect for one (1) year unless revoked by the voter or the administrator of the facility has presented an absentee ballot request from the voter authorizing the administrator to receive absent ballot on behalf of the voter for that election.

The county clerk of the county in which the school district is administered, after receiving the certification of election from the CBEC, shall file a certified copy of the certified results and a certification of the outcome of each race or issue with the county clerk of each county in which any part of the school district lies.
