# ATTORNEY GENERAL OPINIONS

## Opinion No.: 2004-131

Glover, Bobby L.  
*State Senator*

**RE:** Is the repair and replacement of inadequate and unequal school facilities a financial obligation of the local school district or is it an obligation of the State of Arkansas? Q2) If the financial obligation is on the State of Arkansas to repair and replace unequal school facilities in all the school districts, may the General Assembly, subject to a statewide vote of the electorate, propose a measure that would allow for the State of Arkansas to issue general obligation bonds to finance such an undertaking? Q2b) Can such a proposal be done legislatively or would there have to be a constitutional amendment proposed and adopted to accomplish such a proposal? Q3) If a proposal is before the electorate that would allow for the State of Arkansas to issue general obligation bonds to finance the repair and replacement of inadequate and unequal school facilities and it is subsequently turned down by the voters, what recourse would be available to the General Assembly? Q4) Would the General Assembly be obligated to provide funding from other revenue sources to pay for the repair and replacement of these school facilities? **RESPONSE:** 1) Ultimately, this is a responsibility of the State; 2a) Yes; 2b) There does not necessarily have to be a constitutional amendment, assuming the funding source would not require it; 3)4) The General Assembly would have to find alternate sources of funding.

## Opinion No.: 2004-145

Herzfeld, Robert  
*Prosecuting Attorney, 22nd Judicial District*

**RE:** Is it legal, ethical, and appropriate for governmental entities to spend taxpayer dollars in support of or in opposition to a ballot measure on public policy grounds? Q2) What are the legal and ethical reporting requirements, if any, of any governmental entity which is not a "state agency, board, or commission" (i.e., a county office or judicial district office) which expends funds in support of or in opposition to a ballot measure.

**RESPONSE:** Q1) The opinion sets forth the standard that applies to "government speech" offered in connection with a ballot measure. See Opinions 98-204, 2000-162 and 2001-031. Q2) A governmental entity other than a "state agency, board, or commission" is required to report to the Arkansas Ethics Commission its expenditures exceeding \$500 in support of any "legislative question" or "ballot question" as statutorily defined. A.C.A. 7-9-402 (Supp. 2003).

## Opinion No.: 2004-152

Hickinbotham, Boyd

**RE:** Is there a conflict of interests for an attorney to serve simultaneously as city attorney, county attorney, deputy prosecutor, and city judge in the same judicial district, and also serve on a board of directors of a bank? **RESPONSE:** My answer assumes that the question is whether any of the named officers could also serve as bank director. The answer is "yes" with regard to the city attorney, county attorney, and deputy prosecutor. The answer is "no" with regard to the city judge. See Code of Judicial Conduct, Canon 4(D)(3).

## Opinion No.: 2004-154

Lamoureux, Michael

**RE:** Pursuant to provisions of ACA 21-4-102(C)(1) and 21-4-104(d)(1), if an employee is called to duty in an emergency situation during a calendar year and the emergency situation continues into another calendar year, is the employee entitled to one thirty (30) day period of paid leave or two thirty (30) day periods of paid leave? **RESPONSE:** In my opinion, an employee of the state or a political subdivision who is called to duty in an emergency situation, as defined at A.C.A. 21-4-212, is entitled to one thirty-day period of paid leave, regardless of whether or not his service spans more than one calendar year. A.C.A. 21-4-102(c)(1).

## Opinion No.: 2004-164

Berry, Stan  
*State Representative*

**RE:**In addition to regulating the rates charged by the local water and sewer commission for the sale of water by passage of an ordinance, is a city council also required to approve additional fees charged by the commission, such as a tap fee, meter deposit, returned check fee, service call, etc.? **RESPONSE:** State law does not explicitly address this question. However, the applicable statutes suggest that the commission can set fees related to water service without city council approval, but not fees related to sewer service, without city council approval.

## Opinion No.: 2004-165

**RE:**Whether provisions of North Little Rock City Ordinance No. 6826 provide protection for a liquor store owner who seizes the drivers' license of any person who is under the age of twenty-one and attempts to purchase an alcoholic beverage? **ANSWER:** No, as to the bare question of whether the liquor store owner is acting pursuant to the ordinance when he seizes the license of a minor who misrepresents his age to buy alcohol. Nothing on the face of the ordinance suggests that it is intended to address such a matter.

## Opinion No.: 2004-168

Key, Johnny  
*State Representative*

**RE:**Is a taxpayer required, pursuant to provisions of A.C.A. 26-18-404(c) and (d) or any other applicable statute, to request an extension for filing a protest within the initial 30-day period after service of the Notice of Proposed Assessment in A.C.A. 26-18-404(c) in order to be eligible for the discretionary extension period? **Q2)** Is the extension solely at the discretion

of the Director [of DF&A] without regard to any action or inaction by the taxpayer during the initial 30-day period? **RESPONSE:** Q1) Yes. Subsection (c) of this statute establishes an initial 30-day period during which a taxpayer may file a written protest or seek an extension. The provision in subsection (d) that the director may "extend" the time for protesting implies that what would otherwise have been the deadline has not yet arrived. Accordingly, I do not believe a taxpayer can seek an extension once the 30-day deadline has passed. Nothing in the statute suggests that the legislature intended to create an automatic 120-day period during which the status of tax assessments would be in limbo. **Q2)** I believe the taxpayer must either formally protest or request an extension within 30 days of service of notice of the proposed assessment or denial of a claim for refund. I do not believe the Director has the discretion to grant an extension after this 30-day period has run.

## Opinion No.: 2004-171

**RE:**Would deeding the Greene Acres Nursing Home, a nonprofit entity operating in Paragould, to Greene County limit tort liability in the event of a lawsuit? **RESPONSE:** The opinion cross-references Opinion No. 2002-193, which discusses at length the varieties of immunity that might be available to a county-owned nursing home.

## Opinion No.: 2004-173

Thomas, Lindbergh

**RE:**In light of the provisions of the attached Jefferson County Ordinance No. 2003-52, which establishes the anti-nepotism policy for the county, do elected county officials have the right to hire immediate family members on a temporary basis and advise the citizens that because the immediate family member was once employed in said position, before the ordinance was

passed, the elected official has every right to follow this practice? Q2) Do elected officials of Jefferson County have the right to withhold said job positions from other county citizens who might be interested in seeking this employment? RESPONSE: Declined to answer as it does not involve a question of state law, only construction of a local ordinance.

## Opinion No.: 2004-177

Horn, Barbara  
*State Senator*

RE:Who has jurisdiction over an elected county official's property purchases that have been purchased within the budget of the elected county official? Q2) Who has authority to determine who is allowed within an office of an elected county official? RESPONSE: Q1) Unless a statute expressly provides otherwise as to particular property, I believe the elected official will control the use of property purchased for official purposes so long as its use is consistent with the appropriation that authorized the purchase. As the custodian of county property, the county judge may be authorized to challenge a noncomplying use of such property. Q2) Subject to the requirement that the public be afforded access to public records under the Freedom of Information Act and so long as a policy does not keep an official from performing his job, I believe the elected official controls access to his office.

## Opinion No.: 2004-181

Witherell, Stacey

RE:Is the decision of the records custodian to release copies of any training certificates contained in the subject employee's personnel file and withhold any statements, audio or videotapes, that were made for the purposes of an investigation into allegations of a complaint of discrimination/harassment, consistent with provisions of the Freedom of Information Act (FOIA)? ANSWER: Under the facts as stated in the request, the custodian's decision is consistent with

the FOIA. The custodian is not required to compile information or create a record. A.C.A. 25-19-105(d)(2)C). Internal investigation records generated at the behest of the employer are not subject to release because there was no decision to suspend or terminate. The requester is entitled to her own statement and documents that she generated to support her allegations.

RE:Is the decision of the custodian of records to release names, classifications, tenures and salaries for all attorneys employed with each Arkansas state agency and constitutional office consistent with provisions of the Freedom of Information Act (FOIA)? RESPONSE: Generally, yes.

RE:Is all the information requested (names, classifications, tenures and salaries) available under A.C.A. 25-19-105(b)(12) or any other section of the FOIA? Q2) Assuming that the salaries of the non-elected employees of a state agency are available under the FOIA, are the names and tenures of such employees also available, either separately or linked to their salaries and/or tenures? RESPONSE: The custodian's decision to release these documents is consistent with the FOIA.
